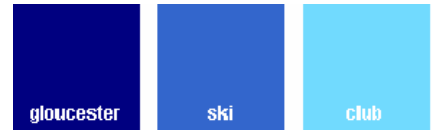

As a result of this parents and spectators at GSC organised events should be prepared to identify themselves to GSC Officers if they are taking photographs or filming. The Club will from time to time video training in order to help in the instruction process.
